Flow meters have been replaced at the wetlands west influent and center effluent.

Street Dept: We attended a meeting regarding the CCMG project on the 15th. Leaf pickup starts a couple says early on October 20th. The engine brake ordinance signs have been ordered. Tree cutting has been mostly completed.

Miscellaneous: We have completed 23 locate tickets. The park restrooms will be open until the weather changes.
